Treasurer's Report

Secretary/Treasurer Legaz reviewed the financial statements with the Directors for the period ending August 31, 2019.

Executive Committee

Moses Seuram, Chair

Chair Seuram reported that the Executive Committee will make recommendations in conjunction with the committee reports.

Budget and Finance Committee

David Legaz, Chair

The Budget & Finance Committee recommends that NYSAR allocate up to \$21,000 from reserves to fund various building projects.

The Executive Committee action: recommends approval. The Board of Director's action: approved.

Issues Mobilization Committee

Andy Burke, Chair

The Issues Mobilization Committee recommends funding a one-year contract through December 31, 2020 with the vendor, Real Strategies to engage voters on a variety of important political and legislative issues affecting REALTORS®.

The Executive Committee action: recommends approval. The Board of Director's action: approved.

The Issues Mobilization Committee recommends establishing a "Rent Control Campaign Fund." This fund will be used to respond to local government efforts to opt-in to New York's rent stabilization law. NYSAR will work with local boards to develop campaigns tailored to their communities in opposition to rent control/stabilization.

Legal Action Committee

The Legal Action Committee recommends that NYSAR contribute \$250,000 in the matter of CHIP v. City of New York.

Organizational Planning Committee

John Vernazza, Chair

The Organizational Planning Committee recommends that the following policy concerning delegations that appear before the nominating committee be repealed:

Candidate delegations; any candidate for Secretary/Treasurer will be allowed one (1) delegation of no more than 3 individuals that shall appear in-person or electronically before the Nominating Committee and each delegation shall have no more than 10 minutes each to make their comments. The Nominating Committee chairperson shall have the discretion to allow additional time to presenters. Delegations will appear directly after their respective candidate has been interviewed.

The Executive Committee action: recommends approval. The Board of Director's action: approved.

The Organizational Planning Committee recommends that the following policy be created regarding the Immediate Past President:

The Immediate Past President serves in the year immediately following the year served as President. The Immediate Past President shall be available as a resource to the succeeding leadership team but is not an Officer of NYSAR. In addition to the other duties set forth in the bylaws or Association policy the President may assign duties to the Immediate Past President including but not limited to travel, attendance at Realtor functions and various other duties. If the Immediate Past President accepts those duties assigned by the President, NYSAR will reimburse the Immediate Past President for necessary travel and expenses pursuant to NYSAR's reimbursement policy. In the event of a vacancy, the position will not be filled.
