Budget & Finance Committee

Jacqlene Rose, Chair

The Budget & Finance Committee recommends that NYSAR take \$100,000 from Reserves to replenish the Disaster Relief Fund.

The Executive Committee action: recommends approval. The Board of Director's action: approved.

The Budget & Finance Committee recommends that NYSAR take up to \$50,000 from Reserves to update the NYSAR trade show booth.

The Executive Committee action: recommends approval. The Board of Director's action: approved.

Treasurer's Report

Jacqlene Rose, Treasurer

Treasurer Rose reviewed the financial statements for the period ending December 31, 2022.

Issue Mobilization Committee

James DiNapoli, Vice Chair

The Issues Mobilization Committee recommends that NYSAR approve up to \$330,000 from the Issues Mobilization Fund in support of a public facing campaign in opposition to state legislation that would impose Good Cause Eviction in New York.

The Executive Committee action: recommends approval. The Board of Director's action: approved.

Legislative Steering Committee

A motion from the floor was proposed and amended as follows:

That NYSAR's official position on Senate Bill 885 should be neutral.

The Board of Director's action: defeated.

Organizational Planning Committee

Steve Rose, Chair

The Organizational Planning Committee recommends that the NYSAR bylaws be amended to identify the Immediate Past President as an officer along with the President, President-Elect, and Treasurer as follows:

Highlighted is added language.

ARTICLE IV - OFFICERS

- D. IMMEDIATE PAST PRESIDENT: The Immediate Past President shall serve as an officer of the Association in the year immediately following the year served as President. The Immediate Past President shall serve as the Chairperson of the Nominating Committee. In addition to the other duties set forth in these bylaws or Association policy the President may assign duties to the Immediate Past President including but not limited to travel, attendance at Realtor functions and various other duties. If the Immediate Past President accepts those duties assigned by the President, NYSAR will reimburse the Immediate Past President for necessary travel and expenses pursuant to NYSAR's reimbursement policy. In the event of a vacancy, the position will not be filled.

SECTION 2. TERM OF OFFICERS:

- A. The elective year shall be January 1 to December 31.
- B. The President, President-Elect, Treasurer and Immediate Past President shall each serve a term of one year.

The Executive Committee action: recommends approval. The Board of Director's action: approved.

Questions were asked regarding the how long Meeting Planner would be live in order to download documents after the meetings, and approximate rollout of the new Meeting Planner app.

It was suggested that NYSAR look into offering the vacant space at the NYSAR building to community organizations in need.
